Multi State Cooperative Society (MSCS) Act, 2002 has been amended recently in 2023. The objective of the amendment was, inter-alia:

- (a) *Electoral reforms in Cooperative sector;*
- (b) *Reforms in the composition of Board, Meetings and Membership; and*
- (c) *Strengthening governance and transparency etc.*

Krishi Pragati Cooperative Limited, Panchkula, Haryanais registered under MSCS Act. To conduct the election of **Board Members 7 (4 General, 2 Women & 1 SC/ST) and 2 Office Bearers (i.e. 1 Chairman & 1 Vice-Chairman)**, **District Magistrate and District Collector, Panchkula** has been appointed as a **Returning Officer** by the Cooperative Election Authority (CEA), Ministry of Cooperation, New Delhi under MSCS Act.

The election has to be conducted as per the provisions contained in MSCS Act and Rules 2002 as amended in 2023.

After the conducting of election in a free, fair and transparent manner, Returning Officer is supposed to seek prior approval from CEA before declaring the Election result of Board of Director as per Rule 19M & Office Bearer as per Rule 19 N of the Amended Rules, 2023.
